About The LEARN Hub

John Howard Society – Durham Region

About the organization

The John Howard Society of Durham Region (JHSD) is the Durham Region branch of The John Howard Society of Canada. The John Howard Society of Canada is a charity that advocates for criminal justice reform through public education and community service.

How they help with record suspensions

The John Howard Society of Durham Region can apply for a record suspension on your behalf. Through this process they:

- Work with the police, RCMP, and government on your behalf
- Get all required court documents/record of proceedings
- Submit the application to Parole Board of Canada
- Respond to requests/further requirements from Parole Board of Canada
- Assist with appeals/proposal to deny

Fee for services

According to their [website](#), **the cost for services vary from case to case**. The fees listed below are shown for reference:

- \$80 for prints to be done at Investigative Solutions Network Inc.
- \$225 for the application processing fee and intake, payable by Cash OR Visa, on your first interview with JHSD.
- \$100 for the local police to perform a local police records check for the area you live in, and for any area you have lived in over the last 5 years (this fee can vary between local stations)
- \$50.00 payable by money order or certified cheque for the Parole Board of Canada, made payable to the Receiver General for Canada, for record suspension processing

If you are interested in using this organization for record suspension services, you are encouraged by staff to reach out to staff to confirm services fees.

Pardons Canada

About the organization

Pardons Canada is a Canadian non-profit organization which assists individuals in removing a past criminal offence from public record.

How they help with record suspensions

When assisting clients, Pardons Canada takes all of the necessary steps required to complete your record suspension. This includes:

- Track and collect fingerprints
- Get police and court records
- Communicating and advocating on behalf of the client with government agencies

Pardons Canada also provides help in the areas of:

- Photograph & fingerprint destruction
- U.S. entry waivers
- Employment and immigration support letters, & more



Pardons Canada

Fee for services

The cost of record suspension services with Pardons Canada is \$945 plus applicable taxes.

To start working with a client, Pardons Canada would need an administrative fee of up to \$250 to begin processing your application. You will have the option to continue paying the remind balance over the period of several months. This payment plan and time period would be determined upon an agreement with Pardons Canada.

Once your record suspension is granted, you will be safe for work and travel, and your record will be removed from public view.
